CUERVO BOARD RECEIVES AND ACCEPTS FINANCING OF \$350,000

December 10, 2009 – Toronto, ON

Cuervo Resources Inc. (CNSX-FE; FWB-CRR; “Cuervo” or the “Company”) wishes to announce that the Board of Directors has received and accepted an offer to provide the Company with \$CDN 350,000 in equity financing. Net proceeds from the financing and the Company’s current cash position will be used to continue to fund the Company’s iron ore exploration projects in Perú and to provide capital for general working purposes. Concurrently, the Company is in the process of seeking a strategic investor to participate in a joint-venture exploration program of Cuervo’s Cerro Ccopane project in the Cusco area of southern Perú.

The non-brokered private placement will see Cuervo issue one million (1,000,000) Units of the Company, at a price of \$CDN 0.35 per Unit, for gross proceeds of \$CDN 350,000 (the “Financing”). Each Unit will consist of one Cuervo common share and one warrant entitling the holder to purchase one Cuervo common share at a price of \$CDN 0.55 for a period of 18 months after the closing of the Financing. If the closing price of the Cuervo common shares is equal to or greater than \$CDN 1.10 for a period of 10 consecutive trading days any time after six months after the closing of the Financing, the Company may accelerate the expiry date of the warrants. The Company will pay a finder’s fee equal to 7% Units in regard to the Financing. The Financing will close on or about December 15, 2009.

The securities to be issued in connection with the Financing will be subject to a four-month hold period from the date of issue.

Cuervo common shares are listed on the Canadian National Stock Exchange (CNSX), and also trade on the Frankfurt Stock Exchange (FWB). Currently, there are 33,423,750 shares outstanding (40,613,750 fully diluted).
